

Rules for the Draw
One sleep, one trip to Orlando, Florida
for the mission of the new Kangaroo House

Conditions for participation

1. The Kangaroo House is organizing a draw *One sleep, one trip to Orlando, Florida*. It is restricted to Québec residents. Donations will be accepted between September 3 to December 24, 2019 at 10AM.

The contest consists of a random draw from all eligible donors for the period of September 3 to December 24, 2019. **The winner will be drawn on December 24, 2019, by The Kangaroo House.**

Eligibility

2. Any Québec resident aged 18 years and over who makes a minimum donation of \$10 to The Kangaroo House is eligible for the draw. Each donor will receive a receipt serving as a ballot for the draw.

The draw is open to anyone whose surname, first name, address and telephone number are written on the ballot, along with the value of their donation. Incomplete ballots and forms will be automatically rejected.

The owners, employees, volunteers, agents and representatives of The Kangaroo House are not eligible.

Numbered postal ballots for donations by cheque will be available by emailing info@maisonkangourou.org or dialing 514 524-4141. Ballots will also be available from the mobile promotional vehicle located in various places during its tour of the three largest cities in Québec: Montréal, Trois-Rivières and Québec City. The dates and locations will be displayed in a timely fashion.

3. The prize will be awarded by a random draw on December 24, 2019, among all eligible ballots received. The value of the prize is \$5,000. The chances of winning will depend on the number of ballots sold.

4. The prize cannot be substituted, redeemed for cash or transferred. It includes:

- A travel credit valued at \$5,000 applicable on a trip to Orlando.*

*If the \$5,000 amount is not used in full, it cannot be redeemed for cash or applied to any other purpose.

Restrictions:

- The gift certificate is valid for a period of one (1) year
- The gift certificate must be exchanged via the CAA-Quebec Travel Centre:

5. The winner will be contacted by telephone in the 15 days following the random draw. If they are absent, a message will be left to announce that they are the winner.

6. Before being declared the winner, the person shall:

Sign the statement and waiver of liability that will be sent to them by the contest organizers and return it to the organizers within 15 days of receipt.

7. If the person selected does not fulfill any of the conditions mentioned herein, they will be disqualified and a new draw will be held in compliance with these rules until a participant is selected and declared to be the winner.

8. By participating in this draw, the winner authorizes the organizers and their representatives to use, if needed, their name, photograph, image, prize statement and place of residence for publicity purposes, without any form of additional remuneration or compensation.

9. The winner may use their prize until December 24, 2020. The winner shall contact the authorized representative of the company to make all arrangements for the trip. After that date, the prize will be null and void.

10. A refusal to accept the prize shall release The Kangaroo House from all obligations related thereto.

11. The person selected shall absolve The Kangaroo House, its advertising and promotional agencies, their employees, agents and representatives of any damages that they may suffer because of the acceptance or use of the prize within or outside of Québec.

12. The organizers of this draw reserve the right, at their full discretion, to amend, cancel, terminate or suspend this contest, in whole or in part, in the case of unauthorized human intervention or for any other cause beyond the control of the organizers that may corrupt or affect the administration, security, impartiality or normal conduct of the draw. Should this occur, they will not incur any liability.
13. The winner will be announced on social media.
14. For the purposes of these rules, the participant is the person whose name appears on the ballot. The prize will be given solely to this person if they are selected and declared to be the winner.
